Carshalton Camera Club ('CCC') (the 'Club') Safeguarding Policy

This policy applies to CCC officers, members or non-members who attend Club events.

The purpose of this policy is to:

- x protect children and vulnerable adults who are CCC members and attend Club events;
- x provide CCC officers, members and non-members with the overarching principles that guide the Club's approach to safeguarding.

For the purpose of this Policy:

- x A child is defined as a person under the age of 18.
- x A **vulnerable adult** is defined as a person aged 18 or over who is, or may be:
 - \circ in need of community care services by reason of disability, age or illness; and/or
 - \circ unable to take care of him/herself, and/or protect him/herself against harm or exploitation.

The CCC believes that children and vulnerable adults should never experience abuse of any kind. We have a responsibility to promote the welfare of all children and vulnerable adults and to keep them safe. We are committed to operating in a way that protects them.

Legal framework

This policy has been drawn up on the basis of law and guidance that seeks to protect children and vulnerable adults, including:

- x Children Act 1989
- x United Convention of the Rights of the Child 1991
- x Data Protection Act 1998
- x Sexual Offences Act 2003
- x Children Act 2004
- x Mental Capacity Act 2005
- x Safeguarding Vulnerable Groups Act 2006
- x Protection of Freedoms Act 2012
- x Care Act 2014
- x Relevant government guidance on safeguarding children and vulnerable adults

We recognise that:

- x the welfare of children and vulnerable adults is paramount, as enshrined in the legislation summarised above;
- x all children and vulnerable adults, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have a right to equal protection from all types of harm or abuse;
- x some children and vulnerable adults are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues; and
- x working in partnership with children and vulnerable adults, parents/guardians, carers and other agencies is essential in promoting the welfare of children and vulnerable adults.

We will seek to keep children and vulnerable adults safe by:

- x valuing them, listening to and respecting them;
- x adopting practices for the protection of children and vulnerable adults through a Code of Conduct (see page 2) and Procedures (see page 4) for CCC officers and members;
- x providing effective management for CCC officers and members through supervision and support;
- x recruiting CCC officers safely, ensuring any necessary checks are made;
- x sharing information about the protection of children and vulnerable adults, and good practice, with children, vulnerable adults, parents/guardians, carers, and CCC officers, members; and
- x sharing concerns with agencies who need to know, and involving parents/guardians, carers, children and vulnerable adults appropriately.

We will review our policy and good practice annually.

This policy was last reviewed on 22nd July 2024.

Safeguarding Code of Conduct

All CCC officers and members are expected to provide a safe and supportive environment for children and vulnerable adults with whom they come into contact in connection with CCC activities.

The behaviour of a CCC officer or member may give rise to allegations being made against them. Allegations may be genuine or misplaced, and may arise from differing perceptions of the same event.

CCC officers and members need clear advice about what constitutes illegal behaviour and what might be considered misconduct, as well as practical guidance about which behaviours constitute safe practice and which should be avoided. This Code of Conduct aims to assist CCC officers and members in monitoring their own standards and practice by raising awareness of illegal, unsafe and unwise behaviour.

Underpinning Principles

- x CCC officers and members:
 - are responsible for their own actions and behaviour, and should avoid any conduct which may lead a reasonable person to question their motivation and intentions;
 - $\circ\;$ should work, and be seen to work, in an open and transparent way; and
 - $\circ~$ should promptly seek advice from a CCC Safeguarding Officer on any incident which gives, or may give, rise to concern.
- x Records should be kept of any incident and the decision(s) made/action(s) agreed.
- x All CCC officers and members should know the names of the Club's Safeguarding Officer, be familiar with the CCC Safeguarding Policy, Code of Conduct and Process, and understand their responsibilities.
- x Breaches of the law could result in criminal prosecution.

Duty of Care

- x CCC officers and members:
 - are accountable for the way in which they exercise authority, manage risk, use resources, and protect children and vulnerable adults from discrimination and avoidable harm; and
 - have a duty to keep children and vulnerable adults safe and to protect them from physical and emotional harm.

Safeguarding Code of Conduct (cont'd)

Exercise of Judgement

- x No guidance can provide a complete checklist of what is, or is not, appropriate behaviour.
- x There may be occasions when CCC officers and members have to make decisions or take action in the best interest of the child or vulnerable adult, where no guidance has been provided.

Power and Positions of Trust

- x As a result of their knowledge, position and/or the authority invested in their role, CCC officer and members may be in a position of trust in relation to a child or vulnerable adult with whom they come into contact in connection with CCC activities.
- x There is potential for exploitation and harm of vulnerable people, and CCC officers and members have a responsibility to ensure that an unequal balance of power is not used for personal advantage or gratification.

Propriety and Behaviour

x CCC officers and members should adopt the highest standards of personal conduct in their dealings with children and vulnerable adults, in order to maintain the confidence and respect of children, vulnerable adults, parents/guardians, carers, CCC officers, members and other members, and the general public.

Infatuations and Unwanted Attention

- X A child or vulnerable adult who is in regular contact with a CCC officer or worker may develop an infatuation with, or show unwanted attention to, that officer or worker.
- x Such situations should be:
 - $\circ\;$ reported promptly to a CCC Safeguarding Officer or other senior CCC officer so that appropriate action $\;$ can be taken; and
 - managed sensitively, maintaining the dignity of all concerned and bearing in mind the high risk of words or actions being misinterpreted, resulting in allegations being made against the officer or worker.

Social Contact and Friendships

x CCC officers and members should avoid developing social contact/friendships outside the CCC, either in person or via social media, with children and vulnerable adults with whom they come in to contact in connection with CCC activities.

Physical Contact

- x CCC officers and members should avoid physical contact with children and vulnerable adults with whom they come in to contact in connection with CCC activities.
- X Unavoidable physical contact should be strictly in response to the child's or vulnerable adult's needs at the time, of limited duration, and appropriate to the child's or vulnerable adult's age, disability, gender, racial heritage and religious belief.

One-to-One Situations

- x CCC officers and members should avoid situations where they are alone with children and vulnerable adults with whom they come in to contact in connection with CCC activities.
- x Ideally a child should be supervised by a parent/guardian and a vulnerable adult by a carer, but if this is not possible, any interaction with the child or vulnerable adult must be in sight of at least one other CCC officer.

Safeguarding Process

The CCC has appointed, or will appoint Safeguarding Officer.

- x An additional Safeguarding Officer may, where appropriate, be appointed temporarily to oversee a specific CCC project in which a child or vulnerable adult is, or may be, involved.
- X The Club will investigate the need for its Safeguarding Officers to undergo Disclosure and Barring Service (DBS) checks, formerly known as Criminal Records Bureau (CRB) checks, and will arrange such checks if appropriate.

Safeguarding Officers:

- x must be CCC members;
- x may not be Designated Officers (i.e. the Chairman, Secretary, Treasurer);
- x are the first point of contact for CCC officers and members who, based on their own observations and/or concerns expressed to them by another person, are concerned about the welfare of a child or vulnerable adult who is a member of the CCC or attends Club;
- x support CCC officers in deciding, when a concern is expressed about a child's or vulnerable adult's welfare, whether action needs to be taken, including (where appropriate) escalation to relevant authorities;
- x are responsible for ensuring that the CCC Safeguarding Policy, Code of Conduct and Process are kept up to date;
- x ensure that records are kept of any incidents and the decision(s) made/action(s) agreed; and
- x will undertake online training on their roles and responsibilities, the cost of which will be borne by the CCC.

If a concern is expressed by any person about the welfare of a child or vulnerable adult who is a member of the CCC or attends Club events:

- x the matter should be reported promptly to the Safeguarding Officer as appropriate; and
- x the Safeguarding Officer should investigate the situation, consulting with other CCC officers as appropriate, to determine to the best of his/her ability whether the concern:
 - 1. is unfounded;
 - 2. arises from poor practice or a breach of the CCC Safeguarding Code of Conduct by a CCC officer or worker; or
 - 3. is a possible instance of abuse or a criminal offence by a CCC officer or worker which needs to be escalated to relevant authorities, e.g. the Children's Social Work Services, the Local Safeguarding Children Board, the Local Authority Designated Officer and/or the Police.

In the case of (2):

- X Where the poor practice or breach of the Code of Conduct is minor, the Safeguarding Officer should alert the CCC officer or worker concerned, remind him/her of the CCC Safeguarding Policy and Code of Conduct, and provide advice on how to avoid a recurrence of the incident.
- x Material malpractice or breaches should be promptly referred to the Safeguarding Officer and the CCC Chairman and Secretary, who will decide whether or not disciplinary action should be taken, e.g. dismissal of the CCC officer or member.

In the case of (3):

x The Safeguarding Officer should promptly advise the Safeguarding Officer and the CCC Chairman and Secretary before escalating to relevant authorities.

In all cases, records should be kept of the incident and the decision(s) made/action(s) agreed.
